
“TALK ABOUT PRESCRIPTIONS MONTH” is celebrated in October. FDA has excellent drug safety publications to help you with your outreach.

Acetaminophen is an active ingredient in hundreds of over-the-counter and prescription medicines. It relieves pain and fever and is often combined with other active ingredients in medicines that treat allergy, cough, colds, flu, and sleeplessness. In prescription medicines, acetaminophen is found with other active ingredients to treat moderate to severe pain.



Taking too much acetaminophen can be harmful.

It can damage the liver. Severe liver damage may occur and may lead to death if you take:

- More acetaminophen than directed
- More than one medicine containing acetaminophen
- Acetaminophen while drinking 3 or more alcoholic drinks every day.

Two ways to identify an unknown pill



Quick Search
(rapid identification, sort pills by color, shape, etc.)



Advanced Search
(includes searching by drug name, inactive ingredients, and more)

New tool from the NIH National Library of Medicine: Pillbox enables rapid identification of unknown solid-dosage medications (tablets/capsules) based on physical characteristics and high-resolution images.
